

I am directed to state that on consideration of the observations and recommendations of the Expert Committee of the Western Regional Committee which visited the institute on 10th May, 1991, the All India Council for Technical Education has accorded approval to the Pravara Institute of Research & Education in Natural and Social Sciences (PIRENS), Loni, Ahmednagar for the conduct of 2-year full-time MBA programme with an anual intake of 30 (thirty) students for the academic year 1993-94 subject to the fulfilment of the following conditions:-

- There should be a separate Governing Council for the MBA programme. It will be constituted and the Chairman appointed as per the guidelines laid down/prescribed by the AICTE from time to time.
- The infrastructural, instructional and other facilities including teaching staff, equipment etc. should be provided as per AICTE norms prescribed from time to time.
- 3. An independent building with required space as per AlCTE norms should be provided <u>exclusively</u> for conducting the MBA programme. Separate rooms for faculty and smaller rooms for elective courses should be provided before the start of the Second Year of the programme.
- 4. An independent library should be established for the MBA Programme with adequate number of titles, books, journals (both Indian & Foreign) etc as per AICTE norms.
- A separate computer Centre with adequate number of PCs, Printers etc. should be established for the MBA Programme.

- No new course(s) should be started and no alteration in the approved intake of students in the MBA Programme should be made without the prior approval of the AICTE.
- The Faculty/teaching staff should be given pay-scales as per the UGC/AICTE guidelines prescribed from time to time.
- B. The admissions should be made as per norms and guidelines of the AICTE /Govt. of India by the Competent Authority.
- 9. The admissions to the Courses should be made only after the minimum requisite/prescribed facilities including the faculty/teachning staff etc. are created/provided and the affiliating University has given permission to start the course.
- 10. The Faculty/teaching staff should be recruited on All-India basis by open selection as per procedure, qualifications and experience etc. prescribed by the AlCTE from time to time. State based selections would be permissible for such posts for which the State Government prescribes "State-based Selection" as a general policy.
- 11. The tuition and other fees will be charged as prescribed by the State Govt. within the overall criteria prescribed by the AlCTE from time to time.
- 12. No Capitation fee or donation shall be charged from the Students/guardians of the students in any form.
- 13. A separate account shall be maintained for the MBA programme and the same shall be audited annually by a Chartered Accountant and be open for inspection by the AICTE or Board or person authorised by it.
- 14. The teaching and other staff should be selected according to procedures, qualifications and experience(s) prescribed by the AICTE from time to time.
- 15. The Management shall strictly follow any further conditions as may be laid down by the AICTE from time to time.
 - 16. An Endowment Fund of Rs.10 lakhs should be created exclusively for the MBA programme and fixed deposit receipt should be in the combined name of the Trust/College and the Director of Technical Education, Govt. of Maharashtra, Bombay. A copy of the fixed deposit receipt should sent to AICTE office and Western Regional Office, Bombay for record.
 - 17. The institute by virtue of the approval given by AICTE shall not automatically become claimant to any financial grant or assistance from the Central or State Government.
